



## Ski/Snowboard Group Options

**Lift Ticket Only:** This is for someone that already has his or her own equipment.

**Lift/Rental Combo:** This is for someone that wants to ski/snowboard but does not want any lessons. You can rent skis, boots, and poles - or- a snowboard, and boots. This package comes with an **all-access** lift ticket that is valid on any lift.

**Beginner Package:** (For ages 4 and up) This package is specifically for beginner skiers/snowboarders in the group. This package includes a lesson (1 ¾ hr.), rentals (skis or snowboard, boots, and poles), and limited lift ticket (limited to the beginner lifts only). **This is a great deal, but the lift ticket is limited**, so be sure to inform your group before they decide on this package. If someone wants to go to the top of the mountain this package is not for them.

**Playland Tubing:** (42" or taller) This is a fun option for those whom do not want to ski or snowboard. Tubes and groomed lanes are included. Boreal has installed a new tubing tow to get you to the top faster. Tubing will be limited to 2 hours during Holiday periods\*. This option can also be added to any other package for only \$10.

\*Holiday Periods: (Nov. 24-27, Dec. 25, 2011 – Jan 1, 2012, Jan. 14-16, 2012, and Feb 18-20 2012)

**\*Please take note of the options above and fill in your Estimated Totals Worksheets accordingly\***

### Other Items of Mention:

**Boots Only:** Boots can be rented for \$15, ski or snowboard.

**Helmets:** Helmets are required for any individual participating in a lesson that is under the age of 18. Participants can bring their own or rent one for an additional \$5/day. *Note: Any individual that desires a helmet can rent one for \$5/day.*

### Group Planning Tips

- Rental forms will not be mailed to your group leader until the Reservation Confirmation form has been received. These forms must be completed prior to arrival and brought to the Group Sales Office – Rental forms **CANNOT** be returned via email or fax.
- Only people that will be getting equipment from Boreal need to fill out a rental form.
- When collecting (filled out) rental forms, please separate into 3 different categories.
  - Rentals Only
  - Beginners Packages
    - Skiing
    - Snowboarding
- Parents or Guardians **must** sign all necessary paperwork if the child is under 18 years old.
- Remember a single payment must be made in full once you come to pick up your group tickets in the group sales office.
- Remember to submit the Preliminary Totals Worksheet ONE WEEK prior to arrival.
- The Boreal Mountain Resort Winter Sports Activities Release and Liability Forms are **ONLY** to be filled out if the group participant is going to tube at Playland.

**AGREEMENT AND RELEASE OF LIABILITY - PLEASE READ CAREFULLY BEFORE SIGNING**

- I accept "as is" the equipment listed on this form. I accept full responsibility for the care of the equipment while it is in my possession. If I do not return the rental equipment by the date stated on this Agreement, I agree to pay the daily rental fee agreed upon in this Agreement for each day the equipment is not returned to a maximum of \$700, depending on equipment type. I also agree to pay for actual damage to the equipment other than reasonable wear resulting from use. Sorry, no cash refunds or credit card reversals. rental equipment is nontransferable. I understand the equipment must be used on the premises.
- I acknowledge that I have received instruction on the use of the equipment and fully understand its use and function. I have made no misrepresentation to Boreal or its employees with regard to any information related to the rental and/or use of the equipment.
- I understand that skiing, snowboarding and use of the equipment (collectively, the "sport") can be dangerous and involve the risk of injury or death. Despite the risks involved and as consideration for being allowed to rent the equipment and participate in the sport, I AGREE TO EXPRESSLY ASSUME ANY AND ALL RISK OF INJURY OR DEATH which might be associated with my use of the equipment and participation in the sport and use of the facilities of Boreal, including the use of equipment, the facilities, terrain parks, and lifts, and participation in instruction, racing, special events, and skiing or snowboarding beyond the ski area boundary (collectively, "use of the facilities").
- To the fullest extent allowed by law, I AGREE NEVER TO SUE AND TO RELEASE FROM LIABILITY Boreal Ridge Corporation, Powder Corp., The United States of America, Department Of Agriculture, Forest Service, and their owners, employees, agents, landowners and affiliated companies (collectively, "Boreal") for any damage, injury or death to me, the above named minor, or user of the equipment arising from participation in the sport and/or use of the facilities of Boreal regardless of cause, including the alleged negligence of Boreal.
- I understand this is a RELEASE OF LIABILITY that will prevent me, the user of the equipment or any heirs from filing suit or making any claim for damages in the event of injury or death to me or the user of the equipment. Additionally, in the event I file or, my child, the user of the equipment, or any legal representative files a claim or a lawsuit arising out of the sport or use of the facilities, I AGREE TO DEFEND, INDEMNIFY AND HOLD HARMLESS Boreal, for any damages, attorney's fees or costs arising out of such a claim or a lawsuit. With the aforesaid fully understood, I nevertheless enter into this agreement freely and voluntarily and agree that it is binding upon me, my child, the user of the equipment, any heirs, assigns and legal representatives.
- I understand and agree that this agreement will be interpreted under California law. I understand that this agreement is severable. If any clause is found to be invalid the balance of the contract will remain in effect and will be valid and enforceable.
- SKI BINDING ADJUSTMENT: I understand that the ski/boobinding system is designed to reduce the risk or degree of injuries but will not release at all times or under all circumstances, nor is it possible to predict every situation in which it will release, and is, therefore, no guarantee for my safety.  
SNOWBOARD, SKI BOARD RENTAL: I understand that the snowboard/boobinding system is not designed to release as the result of forces generated during ordinary use, and is, therefore, no guarantee for my safety.
- HELMET RENTALS: I understand that the helmet being rented is intended for use in the sport. I understand that the helmet has limits to its protective capabilities. I UNDERSTAND THAT THE HELMET CANNOT PROTECT THE USER FROM ALL FORESEEABLE IMPACTS. I understand that the helmet must fit firmly and the chin strap must be securely fastened at all times.
- If I am taking a lesson, I accept the terms and conditions of the Ski School Liability Release.
- I, the parent or guardian of the above named minor, approve this release, waive any right to sue Boreal, and agree to fully indemnify and hold harmless Boreal from and against any loss, liability, damage, cost and expense which Boreal may incur or sustain relating to any personal injury. I, the parent or guardian of the above named minor, certify that he/she is physically fit to participate in the kids club program.
- This document is a legally binding contract which supersedes any other agreements or representations by or between the parties and which is intended to provide a comprehensive release of liability, but it is not intended to assert any claims or defenses which are prohibited by law.

**AUTHORIZATION TO TREAT A MINOR**

On behalf of the above named minor, I authorize and consent to any necessary medical or dental treatment rendered under the general or special supervision of any member of the medical staff and the emergency room staff licensed under the Dental Practice Act and on the staff of any acute general hospital holding a current license to operate a hospital from the State of California Department of Health. It is understood that the effort shall be made to contact the undersigned prior to rendering treatment to the above named minor, but that any of the above treatment will not be withheld if the undersigned cannot be reached. **Winter Sports Activities Release of Liability and Indemnity Agreement**

**READ CAREFULLY BEFORE SIGNING – THIS LIMITS BOREAL/SODA SPRING’S LIABILITY**

I, \_\_\_\_\_, or my child (collectively referred to as “I”, “my”, or “me”) have voluntarily applied to participate in winter sports activities and other recreational activities at Boreal Mountain Resort and/or Soda Springs Mountain Resort, including but not limited to, skiing, snowboarding, snowtubing, sledding, all other winter sports or related activities, and all activities at Boreal Playland, Soda Springs Planet Kids, and Mini-Snowmobiles (collectively referred to as “the sport”). I understand that my participation in the sport poses risks of INJURY and DEATH. The risks include, but are not limited to, loss of control, collisions with other ski area patrons, tubers, and all natural and man-made objects (including, but not limited to, trees, rocks, fences, lift towers, snow making equipment, and over-snow vehicles). The risks also include variations in terrain, surface and subsurface snow conditions, bare spots, bumps, moguls, ice, stumps, forest growth and debris, erosion control devices, rocks, cliffs, steep terrain, avalanches, and traveling in the mountains and beyond the ski area boundary. Other risks include those associated with the use of the facilities, including mountain transportation, lifts, terrain parks (jumps, rails, boxes, half pipes, and other park features), slope style, skier/boarder-cross, performing maneuvers (inverted or otherwise), walking in lodges and parking lots, and participating in lessons, races, and special events (collectively, “use of the facilities”). Despite these risks and all other risks, and **TO THE FULLEST EXTENT ALLOWED BY LAW, I AGREE TO EXPRESSLY ASSUME ALL RISKS OF INJURY OR DEATH** that might be associated with or arise out of my participation in the sport or use of the facilities.

I understand that if I enter a terrain park, I must inspect the elements and terrain before I ski or ride over them to evaluate the risks and degree of difficulty before participating. I understand that throughout the day snow conditions and terrain features will change. I am solely responsible for knowing and understanding my ability to encounter all terrain features.

In consideration for being permitted to participate in the sport and to use the facilities, **I AGREE TO RELEASE FROM ANY LEGAL LIABILITY AND AGREE NEVER TO SUE** Boreal Ridge Corporation, Soda Springs, Powdr Corporation, Auburn Ski Club, or any of their parent companies, subsidiaries, owners, employees, agents, landowners, or The United States of America Department of Agriculture, Forest Service (collectively, “Boreal”) for injury or death resulting from my participation in the sport or use of the facilities, regardless of the cause, including the alleged **NEGLIGENCE** of Boreal. I further **AGREE TO DEFEND, INDEMNIFY AND HOLD HARMLESS** Boreal for any claims, lawsuits, damages, attorney fees, costs or judgments arising out of my participation or my child’s participation in the sport or use of the facilities.

**I UNDERSTAND THIS IS A RELEASE OF LIABILITY THAT IS VALID FOREVER**, and will apply whenever I participate in the sport or use the facilities at Boreal. I understand that this **RELEASE OF LIABILITY** will prevent me, my child, or my heirs from filing suit or making any claim for damages in the event of injury or death from my participation in the sport or use of the facilities. Additionally, in the event I file or my child or any legal representative files a claim or a lawsuit arising out of my participation in the sport or the use of the facilities at Boreal, I **AGREE TO DEFEND, INDEMNIFY AND HOLD HARMLESS** Boreal for any damages, attorney’s fees, or costs arising out of such a claim or a lawsuit.
